Change of Registrant Form

Do I need to fill in this form?

A Change of Registrant form must be completed any time the **Domain** Registrants details change. eg.

- When your company has gone through a company name change and this change is shown on a certificate from the New Zealand Companies Office. Please note we are not requesting a certificate of incorporation, but a change certificate.
- 2. When an individuals name has changed due to marriage or divorce. In this instance we need we need a copy of the marriage certificate or notice of divorce.
- 3. When an individuals name has changed by deed poll or statutory declaration, again we require a copy of the documentation.

Completing the form

These are the steps to go through:

- Print off the Change of Registrant form.
- Ensure all fields are completed.
- A representative of both the Current Registrant and the Prospective Registrant must sign where required - <u>please note these signatures must be</u> <u>originals</u> – not faxed, scanned, photocopied or signed on behalf of (pp-ed.) The signatory must be either a director or senior manager.
- Then, send the completed form with payment of \$28.75 processing fee to:

The instructions must make clear that **The Current Registrant** (called "the Current Registrant") is authorising the changes. They must also identify **The Prospective Registrant** (called "the Registrant") with all the necessary contact details for listing purposes.

The Prospective Registrant must acknowledge the changes, and agree to the terms and conditions published on the reverse of this document. This is achieved by both parties signing the documentation.

If you have multiple domain names that require changing, you must fill in a separate form for each domain name. A separate \$28.13 administration and processing fee is also required for each domain name that needs changing.
